### **Prize Draw Terms and Conditions**

1. These terms and conditions together with any specific rules set out in Prize Draw Notices (as defined below) are the Prize Draw Rules ("Rules") and apply to prize Draws on ICS 1989 Ltd T/A iCS Communications.
